Toilet training help

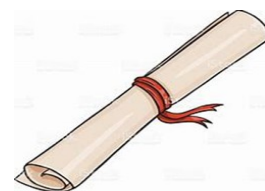
Our school nurse will be in on 7th November at 9.15am.
